




Risk Audit

Example:

- What's the risk category? Reputation and credibility: Not seen as faithful and credible.
- What does success look like? Having a growing church membership who are active in key ministry areas.
- What might stop you from achieving this?
 - a) Doctrinal error
 - b) Not prioritising evangelism
 - c) Failing to train growth group leaders
- How will you mitigate against the risk (current / future?) each with Date Due and Action owner
 - a) Eldership regularly reviewing content of Sunday sermons Date due: 6 March 2024; Action owner: elders
 - b) Etc.
